Re: Recall of batch for cosmetic products (PARLEY BEAUTY CREAM and PARLEY GOLDIE ADVANCED BEAUTY CREAM).

Reference is made to the law No:003/2018 of 09/02/2018 establishing the Rwanda Food and Drugs Authority (Rwanda FDA) especially in its article 8, Paragraph 1 and 13;

Reference is also made to the ministerial order N°20/38 of 26/02/2016 determining the list of cosmetics whose use is prohibited in Rwanda;

Further reference is made to the quality control laboratory results for the tested batch of **PARLEY BEAUTY CREAM AND PARLEY GOLDIE ADVANCED BEAUTY CREAM** which confirmed that there the products contain high level of mercury than the standard requirements.

Considering the negative health effects of mercury on human health, Rwanda FDA **recalls from the market the PARLEY BEAUTY CREAM & PARLEY GOLDIE ADVANCED BEAUTY CREAM** with the following description:

Actions to be taken

1. Rwanda Food and Drugs Authority instructs all distributors, wholesale and all retail shops of cosmetic products to stop distribution and sale of the above mentioned batches of **PARLEY BEAUTY CREAM and PARLEY GOLDIE ADVANCED BEAUTY CREAM** and return to their suppliers;
2. Importers and Suppliers of **PARLEY BEAUTY CREAM and PARLEY GOLDIE ADVANCED BEAUTY CREAM** are requested to receive all quantities returned by their clients and submit a detailed report (quantities imported, quantities distributed, quantities returned and Stock on hand) to Rwanda FDA within 10 working days.
3. Public should stop buying and using the recalled batch for **PARLEY BEAUTY CREAM AND PARLEY GOLDIE ADVANCED BEAUTY CREAM**

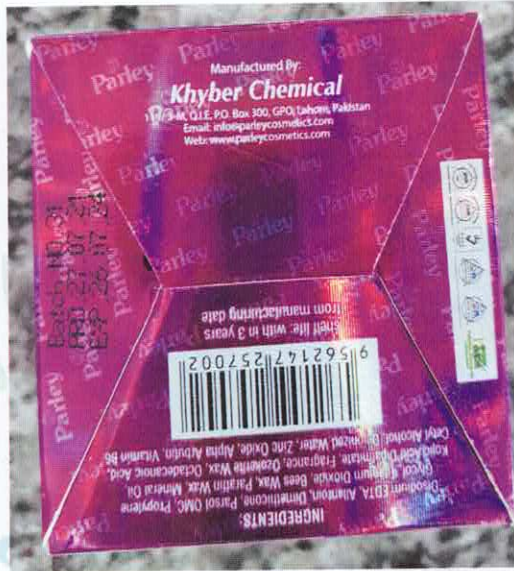
