Impamvu: Guhagarika icuruzwa n'ikoreshwa ry'umuti usukura intoki (Hand Sanitizer) witwa "Pure Skin Stay Safe Hand Sanitizer (Ethanol based)" ukorwa na Africana Buffalo Ltd/Kigali, Gasabo

Hashingiwe ku itegeko N° 003/2018 ryo ku wa 09/02/2018 rishyiraho ikigo gishinzwe kugenzura ibiribwa n'imiti mu Rwanda (Rwanda FDA), mu ngingo ya 8 igika cya kabiri 2 n'icya 13; Hashingiwe kumabwiriza y'umuryango mpuzamahanga wita ku buzima (WHO) ndetse n'amabwiriza ngenderwaho N° DIS/GDL/026 yatangajwe ku itariki ya 16/03/2020 ajyanye n'ikorwa ry'imiti isukura intoki ikozwe muri alukolo (Alcohol based hand sanitizer) aho agaragaza ko mu bihe byo kwirinda icyorezo cya COVID-19, iyo miti isukura intoki igomba kuba irimo alukolo yo mu bwoko bwa etanolo (Ethanol) kukigero kiri hagati ya 70%-80% cyangwa Isopropyle alukolo (Isopropyl alcohol) iri kukigero cya 75%.

Dushingiye ku bipimo bya Laboratwari byakozwe na Rwanda FDA, byagaragaje ko uyu muti wa "Pure Skin Stay Safe Hand Sanitizer (Ethanol based)" utujuje ibisabwa. Rwanda FDA ihagaritse icuruzwa n'ikoreshwa ry'umuti usukura intoki urangwa n'ibi bikurikira:

4. Rwanda FDA iributsa abagura n'abakoresha imiti isukura intoki kubanza kugenzura amakuru ari ku icupa riguriwemo uwo muti, bakitegereza neza ko nibura ugaragaza ibi bikurikira:
 - a. Ingano ya etanolo iri ku kigero cyiri hagati ya 70%-80% (ethanol) cyangwa Isopropile alukolo (Isopropyl alcohol 75%) n'ibindi by'ingenzi harimo glycerine na hydrogen peroxide.
 - b. Nimero iyiranga (batch number), itariki yakozweho n'igihe izarangirira (manufacturing and expiry dates).
 - c. Izina ry'uruganda rwayikoze n'aho ruherereye.
