Re: Recall of adulterated honey products called NYUNGWE HONEY.

Reference is made to the law No:003/2018 of 09/02/2018 establishing the Rwanda Food and Drugs Authority (Rwanda FDA) mainly in its article 8, Paragraph 2 and 13,

Reference is also made to the circular with *Ref No: DIS/CRC/059/FDA/2021* on prohibition of honey adulteration of 4th February 2021 and the previous inspections conducted by Rwanda FDA in response to customer complaints on poor quality of **NYUNGWE HONEY** available on the market.

Further reference is made to the quality control laboratory test results of **NYUNGWE HONEY** which confirmed adulteration of NYUNGWE honey. Therefore, Rwanda FDA recalls the Honey products with the description below:

Actions to be taken

- 1. Rwanda Food and Drugs Authority instructs all distributors, supermarkets, and all retail shops to stop distribution and sale of **NYUNGWE HONEY** and return all quantities to the suppliers within five (5) working days.
- 2. The Manufacturer of **NYUNGWE HONEY** is requested to receive all quantities returned by his/her clients and submit a detailed report (including the names, contacts and quantities returned) to Rwanda FDA within 10 days
- 3. The public should stop buying and consuming the recalled **NYUNGWE HONEY**.

Notes:

- 1) Manufacturers of packaged honey are requested to register their manufacturing premises and products with Rwanda FDA.
- 2) Rwanda FDA reminds all manufacturers that it is prohibited to manufacture and sell adulterated packaged honey.
- 3) All manufacturers and sellers of adulterated packaged honey will be sanctioned;
