2. WHAT YOU SHOULD KNOW BEFORE USING PAMISCAN\*370?

Never use PAMISCAN\* in the following cases:

- If you are allergic to PAMISCAN\*370 solution for injection or any other ingredients in PAMISCAN\*8.

- If you have already had a major or immediate skin reaction delayed after injection PAMISCAN\*(see Adverse Reactions).

- If you suffer from an excess of thyroid hormones (thyrotoxicosis).

In case of doubt, ask the advice of your doctor or pharmacist.

Take special care with PAMISCAN\*370 (370 mg of iode per ml):

As with all iodinated contrast media and regardless of the route of administration and dose, there is a possibility of side effects, which may be minimal but can go up to vital prognosis. These reactions can occur within an hour or, more rarely, up to 7 days after administration. They are often unpredictable, but have an increased risk if you have had a reaction to previous administration of iodinated contrast (see Adverse effects).

Accordingly, if should prevent the radiologist who will conduct the injection if you have experienced an adverse effect during a previous radiological examination with iodinated contrast.

3. HOW TO USE PAMISCAN \* 370 ?

Posology:

4. WHAT ARE THE POSSIBLE SIDE FFFECTS OF PAMISCAN\*370?

Like all medicines, PAMISCAN\*370 (370 mg iodine per ml) solution for injection may cause side effects, although not everybody will not matter. Hypersensitivity reactions (allergic reactions) may be severe and may be in the form of:

- Immediate reactions with itching (pruritus), skin redness (erythema), localized or widespread urticaria, angioedema (swelling of the face or mucous membranes);
- mucous membranes).

  Delayed reactions in the skin such as maculopapular rash, and so exceptional toxic epidermal necrolysis or Stevens-Johnson (significant impairment of the skin lesions such as blisters);
  respiratory symptoms: cough, thinitis throat tightness, difficulty breathing, bronchial spaam, laryngeal edema, respiratory arrest;
  cardiovascular events hypotension, dizziness, malaise, tachycardia, bradycardia, cardiac arrest;
