- Rwanda FDA irasaba abinjiza imiti mu gihugu bose, amashami yose ya RMS Ltd, farumasi ziranguza, izidandaza, amavuriro ya leta n'ayigenga guhagarika gutanga no kugurisha umuti wa Gastro-resistant sodium valproate BP 500mg and 300 mg w'ibinini ukorwa n'uruganda rwa 4Care Lifescience Pvt Ltd rwo mu Buhinde bakawusubiza aho bawuranguriye;
- Abinjije uwo muti mu Rwanda barasabwa guha raporo Rwanda FDA igizwe n'imibare y'ingano y'iyo baranguye, iyo bagurishije, iyagaruwe ndetse n'ingano yose bazaba bafite mu gihe cy'iminsi icumi uhereye ku itariki y'iri hagarikwa.
- Rwanda FDA izamenyesha igihe bizaba byemewe kongera kwinjiza mu gihugu umuti wa Gastro-resistant sodium valproate BP 500mg na 300 mg w'ibinini ukorwa n'uruganda rwa 4Care Lifescience Pvt Ltd rwo mu Buhinde. Bikazaba nyuma y'uko uruganda ruzaba rumaze kugaragaza no gukosora impamvu zatumaga habaho ikibazo cy'ubuziranenge ndetse no kwandikisha umuti mu Rwanda.
