1. WHAT ROCMALINE, oral solution, ampoule IS AND WHAT IT IS USED FOR?

Precautions for use; special warnings

Warnings and precautions:

Special warnings

This medicine contains sulphites.

Use of this medicine is not recommended in patients with fructose intolerance, glucose-galactose malabsorption syndrome or sucraseisomaltase deficiency (rare hereditary diseases).

Precautions for use

Patients with diabetes or on a low-sugar diet should take the sugar cotent of one ampoule (1g) into account in their daily intake.

Take with meals, diluted in a glass of water. 3 ampoules per day

If you take more ROCMALINE, oral solution, ampoule than you should: Risk of diarrhoea at high doses.

Anhydrous sodium sulfite, sucrose, sodium cyclamate, sodium saccharin, plum flavor⁽¹⁾,purified water. ⁽¹⁾Composition of plum flavor: alcoholic tincture of plum, vanilla extract, alcoholic tincture of maraschino cherry and orange, vanillin, ethylvanillin, lactones, dimethylbenzylcarbinol acetyl and butyl esters.
